**1 Name**

#### **9 Temporary Protection (Class XD) visa**

For item 1403 of Schedule 1 to the Regulations, an application for a Temporary Protection (Class XD) visa by an applicant who does not hold, and has not held, a Temporary Protection (Class XD) visa or a Safe Haven Enterprise (Class XE) visa must be made:

- (a) using form 866 (internet) or form 866; and
- (b) either:
  - (i) as an internet application; or
  - (ii) if it cannot be made as an Internet application— using form 866 and posted with sufficient prepaid postage to:

#### **10 Safe Haven Enterprise (Class XE) visa**

For item 1404 of Schedule 1 to the Regulations, an application for a Safe Haven Enterprise (Class XE) visa by an applicant who does not hold, and has not held, a Temporary Protection (Class XD) visa or a Safe Haven Enterprise (Class XE) must be made:

- (a) using form 866 (internet) or form 866; and
- (b) either:
  - (i) as an Internet application; or
  - (ii) if it cannot be made as an Internet application— using form 866 and posted with sufficient prepaid postage to:
