1 Name

This instrument is the *Migration (Arrangements for Visitor (Class FA) visa applications) Amendment (LIN 24/084) Instrument 2024*.

2 Commencement

This instrument commences on 7 December 2024.

This instrument is made under subregulation 2.07(5) of the *Migration Regulations 1994* for the purposes of subitem 1236(6A) of Schedule 1 to the Regulations.

Schedule 1—Amendments

Migration (Arrangements for Visitor (Class FA) visa applications) Instrument (LIN 21/056) 2021

1 Section 3

Insert:

Regulations means the *Migration Regulations 1994*.

2 Subsections 9(2) and (3)

Repeal the subsections and substitute:

- (2) For item 3 of the table in subitem 1236(6A) of Schedule 1 to the Regulations, the applicant must hold a valid passport of any of the following countries:
- (a) Brunei Darussalam;
 - (b) Cambodia;
 - (c) Indonesia;
 - (d) Lao People's Democratic Republic;
 - (e) Malaysia;
 - (f) The People's Republic of China;
 - (g) The Philippines;
 - (h) Singapore;
 - (i) Thailand;
 - (j) Timor-Leste;
 - (k) Viet Nam;

where the passport indicates that the applicant is a national of that country.
